8.1. Individual schools PARCC Test Results and UIP Finished Product
Principal Duran, Santiago Bobian, Megan Archuleta, and Bethany Bak gave a presentation that covered PARCC test results, the root causes for low test scores, and the steps that are being taken to improve test scores.

Pam Levie discussed similar results, root causes, test scores, and steps at Gardner School.

Both Peakview and Gardner Schools reported that they had submitted their UIP once, and, after receiving feedback with recommended changes, will make the changes and resubmit on Friday, January 15, 2016.

8.2. CTE Program Changes for 2nd Semester 2015-2016

Principal Purnell briefly discussed the history of CTE classes, such a auto shop and wood shop, and also reported that we currently have two auto shop classes being taught by Gary Vigil and six construction/design classes being taught by Robinson Payne.

J.J. Perrino, a freshman from John Mall High School who is enrolled in Mr. Payne's class, discussed how much he enjoys these classes.

Robinson Payne gave a brief self introduction. He recently bought a building in Walsenburg that he hopes to eventually convert to a gallery. He also expressed his gratitude for the opportunity to teach at John Mall High School. He also discussed how impressed he was with the students' participation and positive attitudes.

8.3. 2015-2016 Budget Modifications Recommendations

Superintendent Moore reported that an email will be sent with expenditures that are both over and under budget.

8.4. Town Hall Forum on Wednesday, February 3, 2016

The next Town Hall Forum is tentatively scheduled for Wednesday, February 3, 2016, but could be pushed back to February 11, 2016 to coordinate with a bond agent who will address a potential override of Mill Levy.

8.5. Claire Davis Act School Board Meeting Update

Director Sudar reported that there will be a meeting the first week in February to discuss the Claire Davis Act.

8.6. Mill Levy Override for 2016-2017 and Company Assistance

Superintendent Moore discussed bringing in a bond agent to help with Mill Levy Override. He also discussed the importance of recruiting and retention of quality teachers, and reported that, if we are going to pursue an override, we need to do so as soon as possible. It was also decided that simple and factual wording would be the most beneficial when asking for the override. The Board asked to meet with the bond agent prior to they address the community at Town Hall Forum in February.

8.7. New 10th and 11th Grade Assessments for Spring 2016. (PSAT, SAT)

ACT will be taken for one more year as a result of pressure from the public. Sophomores will practice the SAT, and it will be taken next year.

8.8. New Math Curriculum (K-8) "Engage NY", a highly scripted and research-based curriculum

Engage New York in the new math curriculum suggested by General Schools, and, in order to use this curriculum, the district will have to pay for binders and resource printing; not to exceed \$10,000.00.

8.9. Request for Use of Capital Reserve Fund

Superintendent Moore requested that the board approve use of no more than \$8,000.00 to purchase supplies to complete one locker room at the sports complex with the work being completed by Mr. Payne's construct/design students.
