Handouts given to each Board Member.</p> <p>8.2. Washington Underground space request Cindy Campbell with Washington underground requested an additional room for AA, DA, OA groups to use to meet in twice a day once at noon and again at 5pm. Any donation she received from the groups will go towards rent or utilities. She also informed the Board she is in the process of applying for a grant to replace the lighting in the building with LED lights. She will continue to update the Board on her progress.</p> <p>8.3. 
